## Definitions:

AMR = Automatic Meter Reading; one-way communication to a reader

AMI = Advanced Metering Infrastructure; the combination of the electronic meters with two-way communications technology for information, monitor, and control; aka Smart Meter

**EMF** - Electromagnetic Frequency

**PLC** = Power Line Carrier

**RF** = Radio Frequency

Smart Meter = An electrical meter that records consumption of electric energy in intervals (multiple times an hour); communicates that information back to the utility for monitoring and billing purposes. Smart meters enable two-way communication between the meter and the central system.

WiFi = The name of a wireless networking technology that uses radio waves to provide high-speed network and Internet connections.

### Transmission Types:

**AMI/Smart Meter/PLC** = Data is collected through the AMI/smart meter; this data is transmitted via the existing power lines (PLC or Power Line Carrier), which turns all the household wiring throughout the neighborhood into unintential antennas ("dirty electricity"). It may also radiate up into a house from stray currents running in the soil. Dirty Electricity creates many health challenges for people who are already EMR sensitive.

**WiFi-RF** - Data collected by the utility via the Smart Meter is transmitted using RF (radio frequency). This RF transmission exposes all living things to electromagnetic radiation.

#### Concerns:

The loss of the consumer's right to decline the new smart meters and keep the analog meter without penalty; the increasing evidence of the negative health effects accompanying the expanded smart grid; the infringment on privacy due to the continued collection and storage of data on the consumer's activities, including details on when, how and for what they use electricity; the ever-present hacking and cyber-security problems;

accompanying price increases during peak periods; electricity required to run the meter; and increased cost due to the short life of the smart meter as compared to the mechanical meter.

# Action Item:

We want to send an **undeniable message** to our legislators and the Corporation Commission that smart meters are harmful to our health and an invasion of our privacy. We also want them to know that WE, the people of Oklahoma, do not want them used ON OUR HOMES OUR IN OUR NEIGHBORHOODS.

**SEND A LETTER TO THE CONTACT PERSON** in your area requesting no smart meters in the future, and, if they are using them now, to return to using analog meters. Also cite any health concerns or effects you have been experiencing since the installation of a Smart Meter (AMI) on your home or office. Document all evidence.
